Quantum Advisory retains position as signatory to the Financial Reporting Council's UK Stewardship Code

Quantum Advisory (“Quantum”), a leading independent pensions and employee benefits consultancy for small and medium sized schemes, today announced it has retained its position as signatory to the Financial Reporting Council’s (FRC) UK Stewardship Code (the “Code”).

The Code, which is voluntary to undertake, represents £57.3 trillion assets under management and seeks to uphold best practice for those investing money on behalf of UK savers and pensioners. It includes 291 signatories of which Quantum join an elite group of just 19 service providers in the UK.

The FRC states its mission as “to promote transparency and integrity in business.” It sets the UK Corporate Governance and Stewardship Codes and UK standards for accounting and actuarial work; monitors and takes action to promote the quality of corporate reporting; and operates independent enforcement arrangements for accountants and actuaries.

Jayna Bhullar, Senior Investment Consultant and Head of ESG at Quantum Advisory said: “Stewardship is central to how we support our clients and wider network, and remaining a signatory to the UK Stewardship Code reflects our ongoing commitment to maintaining the highest standards of governance - both within our own organisation and in promoting responsible, high-quality stewardship across the industry. We continue to invest in the right people, culture, processes and expertise to help clients meet their stewardship responsibilities effectively.

“The Code rightly sets a demanding benchmark and operates on a voluntary basis. Our continued alignment with its principles, and inclusion among the organisations that choose to put themselves forward and meet its standards, demonstrates the consistency of our approach and the robustness of our governance framework.”
